

**CITY OF COLUMBIA

The Columbia City Council met for a Work Session on Wednesday, July 14, 2010 in the City Hall Council Chambers located at 1737 Main Street, Columbia, South Carolina. The Honorable Mayor Stephen K. Benjamin called the meeting to order at 5:35 p.m. and the following members of Council were present: The Honorable Tameika Isaac Devine, The Honorable Daniel J. Rickenmann, The Honorable Belinda F.
