In accordance with EDA-Special Award Conditions, the City of Columbia must adopt procedures to detect and prevent Resilient Columbia CARES Act Revolving Loan Fund (RLF) borrowers from obtaining funding from multiple federal funding sources (including federal grants, federal loans, and federally guaranteed loans) for identical expenses. At a minimum, the City shall require loan applicants (1) to disclose any other federal funding sources that the applicant has applied for or received for purposes related to the purpose for which the RLF loan is being sought and (2) to certify that no RLF loan proceeds will be used to fund expenses for which the applicant has received other federal funding.
