1. **823 Lady Street** (TMS#09013-13-17) Request for Certificate of Site Plan Approval for new construction hotel. *City Center Design/Development District*
 - **823 Lady Street** (TMS#09013-13-17) Informational Presentation about the design of the hotel. *City Center Design/Development District*

Stephen Zigmund, comprehensive planner, spoke on the request.

Staff recommends approval with conditions, specifically:

- A Pedestrian Connection from Lady Street sidewalk to the parking garage shall be provided. Such Pedestrian connection shall continue across the rear of the building to the pedestrian entry of the parking Garage and to Lincoln Street.
- The Pedestrian Connection from Lady to the parking garage shall have shade trees to provide shade to the walkway and the Patio.
- Materials and details and lighting of the pedestrian connection shall be similar to those used along Lady Street.
- An opportunity for Public Art shall be provided within the pedestrian connection from Lady Street sidewalk to the Garage.
- Design specifications within the right of way shall be coordinated with the Urban Design Planner and the Land Development Administrator regarding the encroachment process
- All Details deferred to staff.

Raj Champaneri, Lady Vista, LLC presented an informational presentation on Aloft Hotels.

Craig Otto, architect for the project, spoke on the design of the hotel.

Guy Jones, business owner, spoke favorably regarding the project.

Mr. Zigmund stated that the applicant has agreed to all staff comments for site plan review.

Motion by Mr. Wynn to approve the request for a Certificate of Design for Site Plan Approval for 823 Lady by virtue of city center design development district guidelines be approved with the proviso that the streetscape connectivity along the left side and along lady street slop are be worked out with staff to be more appropriate to guidelines. Motion includes all staff comments.

Motion seconded by Ms. Grate.

Discussion among Board and staff. Motion approved 6-0.

2. 2216 Wallace St. (TMS#R09113-09-10) Request for a Certificate of Design Approval for new outbuilding. *Cortantown Architectural Conservation District*
Withdrawn
3. 1600 Main St., **Berry's Building** (TMS#09014-04-13) Request for preliminary certification for the Bailey Bill and exterior changes. *National Register Historic Landmark*
Moved to Consent Agenda

4. **711 Gervais Street** (TMS#08912-07-08) Request for changes to a Bailey Bill project.
West Gervais Historic Commercial District

Three adjacent properties came to DDRC in July for preliminary certification for the Bailey Bill and approval for exterior changes. A few changes are proposed from the original proposal for 711 Gervais Street due to unforeseen issues found during the renovation process.

Scott Garvin, architect, presented on the request, which included retaining two original window openings which were found in the façade wall and retaining the large bay on the right side of the structure. Those are the two major changes with demolition on-going. The two buildings have been separated and now have a pedestrian alley in-between.

Motion by Mr. Gressette to approve the project 707-711 Gervais Street as presented with its revised set of circumstances, and according to staff recommendations.

Motion seconded by Mr. Powell. Motion approved 6-0.

5. **1230 Sumter Street** (TMS#11401-03-01) Request for changes to a Bailey Bill project. *Individual Landmark*

This landmark building came before the Commission in January 2015 and was approved for exterior changes and preliminary certification for the Bailey Bill.

The owners planned to replace the terra cotta detailing on the more elaborate six story building with new terra cotta, however have run into some issues. Their proposal is to use a new polyurethane material to duplicate the finish of the terra cotta as closely as possible.

Rick Patel, owner, spoke on the process.

Motion by Mr. Gressette to accept and approve the request for changes to this Bailey Bill project for 1230 Sumter Street based on the materials presented under the fact that this is a test case to utilize this material considering its height on the building and considering staff recommendations.

Motion seconded by Mr. Wynn. Motion approved 6-0.

Elections for chairperson and vice-person will be held at the March 12th meeting.

Motion by Mr. Gressette to postpone the elections for chairperson and vice-chairperson to the March 12th meeting a full member Board.

Motion seconded by Mr. Powell. Motion approved 6-0.

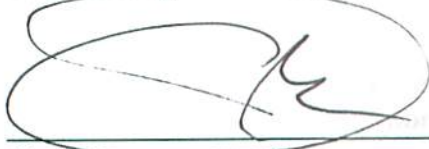
